PLEASE READ PRIOR TO SUBMITTING FORM

- A 10% late filing fee will be charged to account for any renewals received after **March 1**; In addition, to avoid late payment fees through the Treasurer's Office, renewal payment should be received by no later than **March 1**; Businesses with less than \$4,000 of combined Gross Receipts during the previous year are required to obtain a current license, but there will be no charge.
- **Business licenses are valid upon renewal date through December 31, 2022.**
- **A valid business license is required by State law prior to the issuance of a building permit.** Prerequisites to obtaining business license; building, etc. permit. It shall be unlawful for the building official or other authority to issue or allow the issuance of such permits unless the applicant has furnished his license or certificate number issued pursuant to this chapter or evidence of being exempt from the provisions of this chapter. VA Code §54.1-111.
- New applicants or renewals can submit form by mail, in person, by fax, or email to pbrady@warrencountyva.net. In addition, renewals only can be filed online at <https://eservices.warrencountyva.net/> and select e-Commissioner Options.
- Total due can be paid by check payable to Warren County Treasurer and mailed or submitted in person (addresses on front of form) or once application/renewal form is received and processed, your amount due can be paid online at <https://eservices.warrencountyva.net/> and select e-Treasurer Options.
- New applicants must record a fictitious name, if applicable, with the State Corporation Commission at <https://www.scc.virginia.gov/> and must acquire a zoning certificate before a Warren County business license can be obtained; Copies of these documents must be submitted at the time of application.
- **Contractors applying for or renewing a Warren County Business License must comply with all DPOR regulations** <http://www.dpor.virginia.gov/Boards/Contractors> and annually submit a copy of the following along with the renewal form:
 1. Valid VA Contractors License and VA Tradesmen License.
 2. VA Worker's Compensation form 61A <http://vwc.state.va.us/forms/certificate-workers-compensation-insurance-form-61a> **even if no insurance is required.**
 3. A list of Subcontractors, if applicable.
- A County business license is not a substitute for the Virginia State Contractor's License.
- An Out-of-Jurisdiction Contractor who performs work in excess of \$25,000 during the calendar year is required to report those receipts and obtain/renew a business license in Warren County.
- Local Contractors may submit copies of any current business license(s) and gross receipts paid to other jurisdictions for credit.
- Business Personal Property form 762B-Business Equipment or 762M-Manufacturers must be filed annually by no later than **February 15**.
- Failure to renew a business license each year will result in a statutory assessment or a summons for failure to file and pay license fees.
- No business license shall be renewed until the applicant has paid all delinquent business license, personal property, meals, and transient occupancy taxes owed by the business to Warren County. Warren County Code §117-3.
- If any piece of your entity changes (i.e. name, address, phone, email, ownership, etc.), you must notify the Commissioner of the Revenue Office, update new fictitious name with State Corporation Commission, if applicable, and contact DPOR, if applicable, within 30 days of your changes; **These changes include, but are not limited to:**
 - **Closure of business in Warren County.** Failure to notify the Office of the Commissioner of the Revenue of a closure or business that has moved out of Warren County will result in unsolicited statutory assessments, penalties, and interest until your notification is received.
 - **Business/trade has moved location within Warren County.** In addition to notifying the Office of the Commissioner of the Revenue, a new Zoning Certificate would be required. Please notify the Sheriff's office of new contact information for emergencies.
- Businesses or Out-Of-Jurisdiction Contractor's job/contract located in Town must go to the Town Of Front Royal Office on Main Street to obtain a business license and meet zoning requirements.
