

WARREN COUNTY ELECTORAL BOARD MEETING –NOVEMBER 8, 2017 CANVAS OF THE NOVEMBER 7, 2017 – GENERAL ELECTION

The Meeting was called to order at 9:45 a.m. by Chairman, Bill Hammack. The Board Members present were Bill Hammack, Chairman; Linda Taylor, Vice Chairman; and Lee Bowen, Secretary. Carol Tobin, Director of Elections and General Registrar was available to assist the Board.

The provisional ballot meeting began at 10:00 a.m. with no one from the public present. There were eight provisional ballots that were cast. Five due to having no acceptable Photo ID, one due to voter's name not appearing on the Pollbook; one because Pollbook showed name as already voted, and one appeared as other reason. Since four of the five provisional voters that were required to provide acceptable Photo ID did not appear to provide an acceptable Photo ID, the code provides that they have until noon on Monday, November 13, 2017 to provide a copy of their Photo ID in order for their vote to be counted. The Registrar also needed to research reasons for the other provisional ballots; therefore, the provisional ballot meeting was recessed at 10:15 a.m.

The Electoral Board continued with the regular canvas of Elections and proceeded to canvas the results of all the locality precincts. All precinct results were checked against the Statement of Results with the Electoral Board approving and completing this process.

The Electoral Board recessed the regular canvass at 2:15 p.m. and agreed to reconvene on Thursday, November 9, 2017 at 11:30 a.m. the provisional ballot meeting. Members present were Bill Hammack, Chairman and Lee Bowen, Secretary; however, with no information provided at this time the provisional ballot meeting was recessed at 11:31 a.m.

Chairman Bill Hammack called the meeting to order on Monday, November 13, 2017 at 12:15 p.m. The Board Members present were Bill Hammack, Chairman; Linda Taylor, Vice Chairman; and Lee Bowen, Secretary. Carol Tobin, Director of Elections and General Registrar was also present.

The provisional ballot meeting was reconvened and resulted in three Provisional Ballots qualifying to be counted and five Provisional Ballots did not qualify and were not counted by the Electoral Board.

The Director of Elections and General Registrar, Carol Tobin, completed all necessary entries of results and reports. The Abstracts along with the required Write-In Certification for the 15h House District was created and presented to the Electoral Board. The Electoral Board completed the canvas by signing and attesting the Abstracts. With no further official business the meeting adjourned at 4:00 p.m.




